

## History of Practice Includes:

Both Plaintiff and defense sides on many "average" and some exceptional cases in multiple areas:

**Business and Commercial Litigation**: Disputes between or within businesses, or with government entities, over contracts, distribution agreements, executive and employee terminations, safety or defect issues, financial, management and ownership disputes, real estate disputes, public policy or regulation and occasionally IP or antitrust disputes. **Construction Claims and Litigation**: Cases for public and private parties, including owners, architects, engineers and construction companies for both large multi-million-dollar projects and individual homes or commercial buildings.

**Divorce and Family Law**: Representing all parties in divorce and family issues, including estate claims. Particular interest in: (1) business valuations and division of property in divorce; (2) the lawyer/client and expert relations; (3) fair settlements.
